FINAL EXECUTIVE REPORTS AND FAREWELLS

PRESIDENT - KIRATVEER HAYER

The 2022-2023 term was a very difficult and stressful term for me. It started off with being under investigation for allegedly breaching election rules and UWSA positive space policy. After an exhaustive eleven-month long investigation that took up most of my term, I was finally

cleared from any wrongdoing in January of 2023. Despite this obstacle, the UWSA executive still managed to accomplish a lot, much of which is outlined below.

Student Service

- Worked with all UWSA departments in leading a successful return to in person service delivery for students this Fall after the pandemic hiatus.
- Worked with other Exec and University Admin to establish and promote Open Source Educational Resources on campus (OER) as free textbooks options for students. In my first term we provided students with a list of courses that use OERs for fall 2022 semester. This year we are providing a list for spring semester as well. Worked with other Exec and University Admin to establish and promote Open Source Educational Resources on campus.
- Successfully advocated for the implementation the flex parking pass.
- Advocated for more affordable and greater variety of food options on campus.
- Advocated for improved campus security, for example by advocating for getting cameras installed outside student residence
- Created Directors lounge to promote participation in the UWSA and engagement with student body.
- Arranged for UWSA lockers to be provided in Student Centre concourse for use by UWSA directors and student groups.
- Working with alumni association on creating apparel for fundraising, the proceeds of which will go towards a scholarship.
- Hosted student soccer tournament
- Co-organized and hosted successful demo event to introduce student cricket programming at RexPlex where 16 students participated in the match and over 40 signed up to play and/or observed. Now working with University admin to launch cricket as a new intramural sport on campus available to all students this Fall!
- Met bi-weekly with Uwinnipeg senior administration to bring forward student concerns and then follow up with students directly on on-going basis.
- Met each term with the UWinnipeg President Dr. Todd Mondor to discuss emerging student priorities, strategic directions for the organization and to provide direct student representation on wide range of student issues
- Renewed the UPass for UWinnipeg Students
- Attended a presentation by the Downtown Community Safety Partnership (DCSP) and promoted their services for students on campus. Worked with administration in order to improve campus safety.

Financial

 Advocated for the introduction of bylaws which require at least three quotes for goods and services being bought by the UWSA.

- Sourced sustainable promotional materials from more affordable suppliers than were previously used by the UWSA.
- Oversaw changing of UWSA financial auditor where previous auditor was in place for over 10 years. Done to ensure best practice of accounting procedures, oversight and financial reporting to membership.
- Worked with UWSA COO and CFO on creation of UWSA financial policy documents (in progress) to establish a process by which expenditures are authorized.

Governance

- Made UWSA a member to new external advocacy organizations like CASA and MAPSS which has resulted in stronger relationships with our counterparts at the U of M and RRC than in previous administrations.
- Promoted awareness of UWSA elections during roll call and nomination period.
- Instructed UWSA COO to conduct cost benefit analysis of membership in federal advocacy organizations.
- Hired a new Chief Operating Officer who has over 30 years of board governance experience.
- Have been responsive and diligent in my role, currently sitting on 3 UWSA committees (Executive, Finance and Operations, ByLaw and Policy), only missing 1 board meeting (due to technical issue on mobile device during a roadtrip to Toronto) in two years and Chairing the UWSA executive committee which has consistently made quorum.
- Led the changing of UWSA Elections bylaws to create a process that gives candidates more agency in their campaign. Shortened training from 5 days to 1 day. Removed unnecessary Elections Campaign Facilitator positions, saving funds and making the elections bureaucracy more responsive and accessible to navigate for candidates.

As a result of Bill 33 and the subsequently proposed Post-Secondary (Education)Accountability Framework (PSAF) from the provincial government, as well as through health care advocacy for international students, it was my privilege and honour to meet often with government and provide direct student representation. This included meeting with Honourable Jon Reyes, Minister of Advanced Education, Skills and Immigration. Subsequently, In September I provided formal written feedback on behalf of student to the provincial government on as part of the consultation process for the proposed Post-Secondary (Education) Accountability Framework. Our advocacy efforts have been a success as the PSAF has not been implemented at this time and we will continue our advocacy work in this area. Other government engagement within my role included attending CASA lobby week in Ottawa and the June 27th funding announcement and visit at the UWSA daycare from the Federal Minister of Families, Children and Social Development where I welcomed the visiting Minister and spoke about the importance of investing further in the quality of child-care on our campus.

Again, it has been an honour and privilege to work on behalf of our University of Winnipeg (U of W) student family for a 3rd and final term. I have been so humbled to have done so much for our community and students of the University of Winnipeg. I have led through my Anishinaabe worldview and 7 sacred teachings, and this has allowed me to have success in building healthy relationships throughout my tenure as Vice President External Affairs (VPEA). Treating others with those teachings from the heart of love, respect, courage, honesty, wisdom, humility, and truth. This allowed me to stay focus and committed to the UWSA and student needs despite and tough start with investigations part of this term. Fortunately, we overcame and worked hard for our students first.

This year started with our 2nd annual Truth and Reconciliation Week. This is included events to raise awareness and education of the Residential School System, its impact and legacy. We also provided over 300 orange shirts directly to our students. This year we also had an evening with Geraldine Shingoose, (Residential School Survivor/Community Elder). Students were also encouraged to march from the Forks to St. John's Park where a pow-wow was organized for the community.

I also sit on various committee's such as the; Indigenous Course Requirement Committee, Student Appeals Committee, UWSA Executive Committee, Campaigns and External Relations Committee, Indigenous Graduation Powwow Committee, CKUW Radio Board, Canadian of Federation of Students – Manitoba, Healthcare 4 All Committee, UWinnipeg VP Indigenous Hiring Committee, and Freedom Road Film Screening Planning Committee.

I have always advocated and supported for rallies and protests that are important and support our students such as the Orange Shirt Day, Black Lives Matter, Ukraine Support, Against Islamophobia, MMWIG2S, and Justice 4 Eisha Hudson.

Advocating against Bill 33 has always been a big part of my portfolio. It has been a privilege to build good respectful relationships with all parties, including the Minister of Advanced Education, Skills, and Immigration Honourable Jon Reyes, NDP member Jamie Moses, and Liberal party leader Dougald Lamont. Agenda items included: Post-Secondary Education Accountability Framework policy consultations and advocacy, International Student Health Care, and Indigenous student success. Part of the advocacy process, I had the honour of being invited to attend the Throne Speech at the Legislative Building. First time attending this event, I was so humbled for the invite and the networking was incredible.

Health Care for All has been a campaign I am proud to be part of. Advocating on behalf of international students for free health care, especially a hot topic during the pandemic, and will continue to put pressure going into the upcoming provincial elections.

Being a member of the provincial executive committee of the Canadian Federation of Students has been amazing in terms of connecting and networking with students from all across Canada.

I attended the Atlantic RISE (Racialized Indigenous Students Experience) in Pictou, Nova Scotia, and the CFS Annual National General meeting in Ottawa.

It was a humbling experience to bring the 2nd Annual Unsheltered Relatives Initiative. Raising over \$2,5000 towards hot meals and beverages to our unsheltered relatives on the streets of Winnipeg was such a humbling experience for our student volunteers. To provide a small kind gesture really means the world to some that really struggling in life. To see that joy from something simple as hot meal, helps you realize how blessed we are in our academic journeys. Remember people go to bed and pray to be where we are as current students. We partnered with the Feast Bistro once again this year for the food (chilli, bannock, and a cookie).

Was also proud to be part of the planning committee to bring the Freedom Road 40 film screening, that was 4 years in the making, due to the pandemic.

We also, as a team, worked to ensure all student group funding requests were accommodated to some extent, and if we were unable to help, we provided the proper channels that can.

Currently I am so excited about the new partnerships and initiatives I am currently working on such as:

Treaty 1 Land Development – continue to keep a great relationship and dialogue with Chief Gordon Bluesky – Chairperson of Treaty 1 Corporation. There are very exciting partnership opportunities, I will continue to help promote the U of W as a leader for these opportunities. Part of the efforts working with Treaty 1 Corporation is the flags of Treaty 1 and Metis nation being raised permanently in the front of our campus.

Justice 4 Eisha Hudson — Working with the U of W administration towards a scholarship/endowment fund. The goal is to raise a minimum \$10,000. Working with the parents of Eisha Hudson, we will be going public to raise the rest of the funds. We will continue to work with the UWinnipeg Foundation on this initiative.

CKUW Radio – I will be starting a radio show/podcast called "Engaged" focused on hyping up student engagement, highlighting student group, events, and community news. This show will also feature music reflecting our student groups each episode.

U of W Daycare – I will continue to work with the daycare on Indigenizing the playground/ outdoor areas at the daycare and helping on grant proposals.

Student Indigenous Advisory Circle – The circle will work with the board to ensure Indigenous ideas, concepts, and input is honoured/respected within the UWSA.

In term of addressing safety issues on campus, we will continue to work with the Downtown Community Safety Partnership organization to see how students can benefit from their services moving forward.

In closing, again it has been a privilege and honour to work for the UWSA and our student family. Wish you blessings and love in all your academic journeys.

In the early portion of my term, I focused on reviewing and improving the management and amenities of the UWSA Access Lounge after having been closed during the Covid-19 pandemic. The room has reopened with upgraded safety measures and work is currently underway to make it a more useful and enjoyable space for students living with disabilities.

During the summer months, my attention turned to support the mental health and wellbeing of students. RACIALIZED STUDENTS' DIRECTOR - OYIN AKINBOYE

As the Racialized Student Director, I have worked diligently to create a more inclusive and welcoming environment for BIPOC students at our institution. In this final report, I would like to highlight the success of my efforts in partnering with a highly qualified BIPOC lounge coordinator and creating a memorable Black History Month program.

Selection of BIPOC Lounge Director: One of my main priorities as the Racialized Student Director was to create a safe and supportive space for BIPOC students on campus. In order to achieve this, I carefully selected a highly qualified and experienced BIPOC Lounge Director to oversee the lounge space. 2SLGBTQ* STUDENTS' DIRECTOR - BRIE VILLENENUVE

I was voted in during the By-Elections in October 2022. As a first-year student, I took on a big task of running, though I feel the efforts I have done has been greatly beneficial for my community.

The first few months of my term I spent getting to know the community and hearing their concerns about campus safety, UofW systems, professor support, etc, as well as experiencing

this environment myself as a queer person. By late January I had started the process of working with other UWSA members, Ted Turner, Kirt Hayer, and a couple transgender students who have been harmed by UofW's naming system, specifically being deadnamed. Our goal was to go over what has happened in our time here as trans students and how it has been disrespectful and harmful, and to bring this information to administration. In Early February I met with these folks again as well as Colin Morrison, UW General Counsel, to address what has been done and to discuss where things have gone wrong and need to be improved. A follow-up has yet to be discussed, likely due to the stress of midterms and the anti-trans event that took place on March 3rd.

During the process of discussing names on UofW system, it was brought up that the Duckworth Centre does not have a gender neutral changeroom or nearby washroom, as well as the binary changerooms feeling unsafe and feels too exposed for many students who do access it. Along with that, it was discussed that the access to gender neutral washrooms on the main campus is very sparce, and that they are also the designated accessible washrooms. This conversation is expected to go forward in the coming months with the designated UWSA members including Accessibility Director, along with transgender students, disabled students, and the proper UofW administrators.

On March 3rd I held a rally for Two-Spirit, Transgender, Non-Binary, and Gender Diverse Safety on campus. This was in response to UofW allowing anti-trans rhetoric under the vise of academic freedom and the lack of action they took after many trans students, staff, community members and allies had called for action. As well as the above mentioned. UofW has claimed to be inclusive and safe; yet our community had to fight against blatant hate speech.

I have enjoyed my time in this position getting to know the UWSA community and the 2SLGBTQ+ community on campus. I hope to continue to be a leader in my community and advocate for beneficial change as I continue my education at UofW.

CHIEF OPERATING OFFICER REPORT

I joined the UWSA on April 25, 2022, as the COO. The first 11 months have been a learning curve, with a growing understanding of the complexities of the organization and the component parts.

My initial few months were establishing the return to campus of staff and UWSA services to students. We re-established the food bank, transitioned Safe Walk to the UW security services

who have the staff and expertise to ensure safety, re-opened the lounges and began providing space and supports to student groups, as well as social activities including Roll Call and Snowed In. The Program, Events and Marketing and Communications managers and staff have done an exemplarily job transitioning back to campus and supporting students.

The Daycare continues to provide valuable service to students, faculty, staff and the community. It runs efficiently under the UWSA Day Care Director. The playground was enhanced through grants obtained by the Director and future expansion plans continue to be explored with the UW administration.

Two investigations against the President which were begun by the previous CEO and which were committed to by the board and executive were completed. The Human Resources investigation was completed by Harris and Associates led by Barbara Axworthy and the second, election related complaints were completed by Sherri Walsh of the law firm Hill Sokalski Walsh. Both investigations were led by independent, arm's length and unbiased professionals and included interviews of both the complainants and the respondent. Neither investigation resulted in a finding that the behaviour of the president reached a threshold that could be considered actionable under the existing policies of the UWSA. As such the investigations are closed and no further action will be forthcoming.

Major initiatives which were completed at the direction of the Executive was the change of Auditors as it is a best business practice, the migration of the payroll system to Payworks a local Winnipeg Payroll provider and the negotiations with the UWSA staff represented by local 153 of the MGEU. These negotiations are pending ratification by the staff which will then be submitted to the board for approval.

The General Manager with support from the Communications team facilitated the by-elections in January and are in the process of completing the annual general election. The number of candidates is well above recent years and shows a vibrant and engaged student population who are interested in student politics and key issues facing students and the University today.

I look forward to working with the newly elected and returning Executive and Board Members and strengthening the UWSA.

ELECTION BY-LAW CHANGES

UWSA Elections have experienced several periods of conflict and in 2020 and 2021 underwent significant reforms; however, because of the COVID-19 pandemic and campus restrictions, UWSA By-Election 2022 is the first major on-campus election where we have been able to assess the new regulations in full force. While many of the election reforms worked well and

created a positive learning environment for electoral candidates, some rules proved ineffective, unenforceable, or problematic.

The reforms performed were designed to support the continued growth of the UWSA's democratic process. This proposal is informed by the observations of staff throughout the UWSA By-Election 2022 and with respect and observance to the legacy of UWSA Directors, Executive, election candidates, and general membership who have participated in consultations about the UWSA Elections over the past three years.

Changes focuses on these areas for improvement:

- 1) Overuse of By-laws
- 2) Candidate Training, Campaign Preparation, and Election Timeline
- 3) Campaign Materials
- 4) Election Management and the Allocation of Duties
- 5) The Election Accountability Board (EAB)
- 6) Complaints and Anti-Harassment Policy
- 7) Election Slates, and Campaigning Opportunities

ALL CANDIDATE TRAINING AND CAMPAIGN PREPARATION WEEK

This year the General Election candidates had a 2 week All Candidate Training and Preparation period, This gave candidates sufficient time to:

- Complete required training modules
- Notify Communications of needed campaign materials support
- Create their own posters, and campaign materials
- Prepare Campaign platforms
- Attend required Campaign training session
- Attend headshot sessions with Communications team
- Create a campaign plan.

This extended period helped staff give better support to Candidates, as they were able to handle the work load more efficiently.

IN-PERSON MEETINGS

The UWSA Board of Directors moved to start having hybrid board meetings, first in UWSA history, and first time since March 2020 having any form of in-person Board Meeting. We look forward to our first hybrid AGM on March 20th.

MEETINGS AND LIASING WITH UW ADMINISTRATION

We held regular meetings with all levels of the UWinnipeg Admin to move UWSA special projects and strategic initiatives forward in support of Executive and Board campaigns and

priorities. These include a bi-weekly meeting with the UWinnipeg Registrar where there is a specific focus on academic items as well as meetings each term with the President's Office to discuss emerging student pririties and strategic directions for the organization. Liaising with the UWinnipeg Administration to further UWSA initiatives and priorities as established by the Executive and Board was, and continues as, daily work within the Special Projects Department.

GOVERNMENT LOBBYING

As a result of Bill 33 and the proposed Post-Secondary (Education) Accountability Framework we worked to hold several meetings between members of the Executive with the sitting provincial government and opposition MLAs.

DAYCARE PROJECTS

We worked with The UWinnipeg Foundation to receive and administrate federal funding for a new green/play space project at the UWSA Daycare. As the fund included a specific focus on indigenous program elements and learning engagement, we worked to ensure the UWSA Student Indigenous Advisory Circle (SIAC) was central to community consultations with an indigenous led design firm in visioning sessions for the project. We are currently working with the SIAC, UWinnipeg Foundation, the federal government and UWinnipeg to further finalize the scope, schedule and budget for the project. We also worked at length on a proposed daycare expansion project that is currently paused as UWinnipeg works toward a establishing a campus plan.

U-PASS

We worked with the City of Winnipeg and UWinnipeg to re-negotiate our service agreement and subsequently re-introduce the U-Pass program.

MORE THAN A DOOR CAMPAIGN

It was a great privilege and honour to continue to work alongside UWSA Community Liaison Director Sarah Anderson in support of the More than a Door Campaign, the result of which saw the level of accessibility on campus substantially improved by the addition of accessible door upgrades.

PARTNERSHIPS AND AGREEMENTS

PACE and WUSC have been two partnership areas with a recent focus. Our partnership with Lifetouch to provide grad photos for students on campus was also renewed and renegotiated this year.

STRATEGIC DEVELOPMENT AND RISK MANAGEMENT SUPPORT

This is an ongoing and dynamic area that includes working closely with the Chief Operating Officer as well as the Exec and Board.

Most of the package is cleaning up language, and old by-laws that no longer are relevant. Key change is to how quorum of the UWSA Board of Directors meetings will work, resembling the way UWSA Committees work. The Chairs, and Secretary will no longer be counted towards quorum meaning that if one must miss a meeting they don't count against quorum. Co-Directors will both share a seat that is counted towards quorum, this brings down the number needed for quorum and eliminates co-directors cancelling each other out if one attends and the other doesn't. All of the by-law changes have been available for the last month on the website.

Good Evening fellow students and UWSA Board Members. With everything going on, tonight, I want to read out a statement that I have prepared. It is written from the heart, so all I ask is that you listen to it with an open mind.

This has been a tough few weeks. Tough on me, tough on our staff, tough on the board of directors, and of course, tough on the UWSA and the entire student body. As someone in a leadership position, I expect a certain amount of politics. However, this has gone too far. Right now, our student union is in trouble, and as President, I will do everything I can to resolve our outstanding issues and move us forward, together.

As leader, I want you all to know that I take accountability for this situation. While I don't agree with everything that has been said about me, I want you to know that I see what is happening and it keeps me up at night. When students get together and write a letter criticizing me, for example, I hear them. I take it seriously. When I have an executive member who is making complaints about me, I hear them too. I take it seriously.

However, things have gone too far and are spinning out of control. Small incidents are being taken out of context and twisted to be something they are not. Not only have people attacked my character and slandered me personally, but the recent vote was suspended and the students collectively have not had their vote count.

There has been lots of discussion around our Positive Space Policy. The irony is that this has not been a positive space for me. My mental health has suffered. My physical health has suffered. While some would portray me as a bully, in many ways, I am the one being bullied here. I do not say this for sympathy, I only say it to pull back the veil on what is really happening here.

My whole life I have dealt with challenges. Some of them personal. Some of them external. And it is not lost on me that, as a person of colour, sometimes we are targeted in ways that others are not. In instances like these however, the very tools that are

designed to protect me and other marginalized students are being weaponized against individuals of those same groups.

Thankfully, as of last night, the EAB has recognized that they were not authorized to suspend, or recommend the suspension, of the election results. These results, per the UWSA by-laws, must now be ratified. Thankfully, cooler heads have prevailed.

I hope that this brings our organization together and helps us move forward. However, I worry that there are some who want to pursue their own personal agendas. That they want us to spend our whole year on investigations and arguing. Sometimes arguments can occur but they want to make it so that we get nothing accomplished despite our disagreements.

On the other hand, I would rather move forward as an organization and work collaboratively with all of you. I would like to hold strategic planning meetings with the board. I would like to initiate advocacy campaigns with the administration and government. I would like to host fun events, identify new supports for students, ensure that our organization runs smoothly, and make it so that the UWSA is left in a stronger position at the end of my term than it was at the beginning.

I know that not everyone on this Board voted for me. But 75% of voters did. The election is now behind us. I ran uncontested, and next year, the people who do not like me will have a chance to vote for a new candidate that they support. But for the next 365 days, I would ask that everyone put down their anger and try to work together. It will not be helpful if we spend our entire year fighting each other. This is not for me, but for the UWSA and for the students.

- a. Kiera A. Feels it is a ridiculous that the EAB approved Kirt's results, and waited 6 days to share that decision.
- b. Avery K. agrees with Kiara
- c. Cliff S. Would like answers as to why it would take 6 days for it to take to hear this and does not know why it took so long. It was decided on the 24th and it was only announced today. It feels like that information was kept from students.
- d. Dagen P. Cliff S. raises valuable points, there is a section of the students that do not have faith in the organization. The UWSA and the board need to find a path forward and think about the feeling of disillusion with this institution students have. Lots of this gets turned into who said what.
- e. Savannah J. I would like to know what specifically the UWSA has done to acknowledge and what discussions were had internally regarding the concerns brought forward in our open letter?
- f. Jeremy **K.** Very little was done outside of a post on what is going on, there was very little done to inform the public about the issue. Had to search for information to find it.
- g. Karn S. Believes the board and students should respect and follow the election result.
- h. Kaynat P. We should go with the results since 75% of students voted in favor.
- i. Sarah There is lack of transparency in terms of our lines of reporting. Out losing of quorum, and maybe we can fix some lines of reporting.
- j. Kirt H. Aware of everything brought forward and takes it seriously, but a vocal minority are using intimidation tactics to force him to resign. Looking at legal action. Are we creating a governance structure that will prove people's innocence? He will be bringing into the investigation other candidate's cases of precampaigning, looking to try and collude and making comments based on race.
- k. William S. UWSA needs to work on good communications.
- I. Reza H. This has not been easy. Our students will be the center of any discuss and thanks student groups.
- m. Shawna P. In full support of students, and acknowledges that not a majority of students voted, only 8.3%. Part of our responsibility is giving students faith in the election system and sitting president. Shawna P. has not felt safe this last year, and when meeting in person was being escorted by security. Looking for a better action

- than the EAB and lack of action shows that we are fine with student groups complaints, more needs to be done. To close the chapter with the UWSA and it has been triggering and wants to see this investigation happen.
- n. Sarah A. As a board they do have to go through due process. Just because there isn't a result right now does not mean they are not looking at it.
- o. Kiera S. Understands there is a process that must be done, and it feels like there is a slap in the face not being transparent. Will Kirt's statement from the reports be made public?
- p. Umar A. does believe we should continue with the election results. 445 students voted for Kirt. A democratic process is open to opinions and criticism. Conflict may occur but does see that the EAB failed to provide mediation when it was supposed to.
- q. Anjola A. Actions are being taken but cannot comment on much of it and takes responsibility for the delay on the EAB results. And thanks students for coming. Encourage people to participate in a continued way. Staff is greatly reduced right now.
